

Addendum

This addendum sets out the changes to be carried out in the Combined Scheme Information Document ('SID') of the schemes of DSP BlackRock Mutual Fund ('Fund') with effect from August 22, 2011.

CHANGE IN NOMENCLATURE OF DSP BLACKROCK SAVINGS MANAGER FUND ('The Scheme')

With effect from August 22, 2011, the nomenclature of DSP BlackRock Savings Manager Fund is being modified to DSP BlackRock MIP Fund. Consequently, the options available under the present DSP BlackRock Savings Manager Fund viz. Monthly Income Plan (MIP) and Quarterly Income Plan (QIP) will be renamed as 'Monthly Dividend Option' and Quarterly Dividend Option' respectively.

Pursuant to the above, following modifications will be carried out in the Combined Scheme Information Document ('SID') of the Fund.

1. Section I - Highlights of the Scheme:

In the table pertaining to the Scheme,

(i) the name of 'DSP BlackRock Savings Manager Fund' will be replaced with "DSP BlackRock MIP Fund (Monthly income is not assured and is subject to the availability of the distributable surplus."

(ii) within the row, 'Options available', the name of the existing options viz. MIP (Monthly income is not assured and is subject to the availability of distributable surplus) and QIP will be replaced with "Monthly Dividend" and "Quarterly Dividend" respectively.

2. Section II - Definitions:

The disclosure within the row, 'DSPBRSF' will be replaced with the following:

DSPBRMIPF	DSP BlackRock MIP Fund (Monthly income is not assured and is subject to the availability of distributable surplus)

3. Section V - Information about the Schemes

In the section, 'A. Type of Scheme', the existing disclosure pertaining to 'DSPBRSF' will be replaced with the following:

DSPBRMIPF	Open ended income Scheme, seeking to generate long term capital appreciation as well as current income. Monthly income is not assured and is subject to the availability of distributable surplus.

4. The name of DSPBRSF and DSP BlackRock Savings Manager Fund wherever else they appear in the Combined SID will be replaced with DSPBRMIPF and DSP BlackRock MIP Fund respectively.

5. The name of the options viz. Monthly Income Plan (MIP) (Monthly income is not assured and is subject to the availability of distributable surplus) and Quarterly Income Plan (QIP) under the current DSP BlackRock Savings Manager Fund, will be replaced with "Monthly Dividend (MD)" and "Quarterly Dividend (QD)" respectively.
